NOTICE TO BIDDERS**

Sealed bids for Contract No. 4568.09, for the West Market Street Drainage Improvement Project including installation of catch basins and piping, located on West Market Street in the Village of Rhinebeck, are sought and invited by the Village of Rhinebeck, Dutchess County, New York, as set forth in specifications dated March 4, 2016, prepared by Crawford & Associates Engineering, P.C., 4411 Route 9, Suite 200 (The Flanders Building), Hudson, New York 12534.

Bids will be received at the office of Patricia Coon, Village Clerk, 76 East Market Street, Rhinebeck, NY 12572, until 3:00 p.m. on March 31, 2016. The bids will be publicly opened and read aloud immediately thereafter at the Village of Rhinebeck, 76 East Market Street, Rhinebeck, NY 12572.

The Village of Rhinebeck is requesting bids for the construction of drainage improvements on West Market Street. The modifications to the site include selective demolition, removal of an existing catch basin and piping, installation of three new catch basins and piping, and installation of new curbing. Work occurs within the NYSDOT Right-of-Way for State Route 982M and on private property; the Contractor shall work under the Village's Highway Work Permit and shall provide proof of all appropriate insurances. All activities on site shall be consistent with State and Federal regulations.

All bid documents and all contract documents, including specifications governing the contract (Bid Documents), may be examined during regular office hours at the office of the Village Clerk, 76 East Market Street, Rhinebeck, NY 12572, between the hours of 9 a.m. and 4 p.m., on or after March 4, 2016. This job is subject to prevailing wages. Wage rates are provided within the Bid Documents.

Copies of the Bid Documents may be examined and obtained from the office of Crawford & Associates Engineering, P.C., 4411 Route 9, Suite 200 (The Flanders Building), Hudson, New York, upon making a deposit of fifty (50) dollars for each set of specifications obtained. All payments shall be in the form of a check or money order made payable to Crawford & Associates Engineering, P.C.

Starting promptly at 10:00 a.m., prospective bidders are advised that there will be a mandatory pre-bid meeting on March 16, 2016 at the site on West Market Street, Village of Rhinebeck, NY 12572. All questions from the pre-bid meeting will be answered in writing via email within one week of the meeting. To receive addenda/answers prospective bidders must register with Michelle Ewert at Crawford and Associates Engineering. To register, Contractors shall send an email to [michelle@crawfordandassociates.com](mailto:michelle@crawfordandassociates.com) expressing your interest in the project. The Village and Crawford and Associates are not responsible for providing addenda to Contractors who do not register via email.

Each bidder must provide a security deposit with her/his bid in the amount of not less than five percent (5%) of the base bid in the form of a certified check or a bid bond subject to the conditions of the bid documents.

No bid will be accepted unless a signed Certification of Non-Collusion is submitted with the bid.

The Village of Rhinebeck expressly reserves the right to waive any informality in or to accept any bid or to reject any and all bids or to award on any or all items as the interest of the Village may appear to require.

No bidder may withdraw his bid within ninety (90) days after the actual date of the bid opening.
