The Village of Rhinebeck invites sealed bids for the ASHER ROAD AND ROCKEFELLER LANE – PAVEMENT REHABILITATION set forth in Contract Documents prepared Thomas M. Mannix, PE.

The Village of Rhinebeck is soliciting bids for the pavement rehabilitation/paving of Asher Road and a portion of Rockefeller Lane under the NYSDOT CHIPS Pavement Program. This project is broken into two sections, Asher Road and a 410' section of Rockefeller Lane. Asher Road is 580' long and 20 to 34' wide. Rockefeller Lane section is 410' long and 16' wide. The plans include 500+ tons of asphalt, misc. subbase, drainage improvements and pollution control .
